Ms. Wright welcomed new employee Blanca Navarro. She will conduct a brief introduction. She is the Compliance Technician and Programs Manager. She has 23 years of experience in Public Housing and Affordable Housing. She is council member for the City of Selma. She is in the second year of her first term. She started off as an Office Assistant. She has completed audits, updated and reviewed Housing policies and procedures. Programs she worked with include. but not limited to low income public housing, farm labor, migrant, HUD (various rental assistance), tax credit, HOME including CBDG, project based voucher, Home Key, RAD conversions, permanent supportive housing and home ownership. She has experience with audits with various agencies. She has various certifications that include. but not limited to California Certified Regional Manager, Tax credit certification, blended housing specialist HOME, Certified Farm Labor Manager and others. She is excited to be here.

Commissioner Antia Evans welcomed Blanca.

Chairperson Santos Garcia congratulated Blanca.

Blanca spoke about collaborating by other housing employees.

Ms. Wright gave her Executive Director report. She continues to have her bi-weekly meetings with HUD. She completed the Executive Director orientation. She was able to set up a meeting with the Consortium to find out what services and benefits are available to us. Monthly meetings will be scheduled with them. They offer trainings and HR services. It puts HACM at a better standing with HUD. Blanca will finalize the MORES audit for us. Yardi is a BEAST! HACM has a few proposed projects on the table. Ms. Wright reached out to Commissioner Montes to help out with reaching out to RH Builders. They submitted a couple of locations one of the locations is Gateway Inn, the second location is Knights Inn and third is Springfield suites for our home key project. Main focus will be chronically homeless and DSS. They will be Board Meeting to finalize the location. We set up a Landlord community event. Invitations were sent out. We are hoping you can join us. The purpose is to put us at the forefront and reestablish the relationships, and also to reestablish our landlord relationships.

Sadly, our Police Officer has retired and moved to Fresno. Unfortunately we will not get a Community Officer for some time. Commander said they are so short staffed that it will take a while before we get an Officer.

Chairperson Santos Garcia would like to visit again this topic of our Community Officer/Security. Chairperson Santos Garcia inquired with Commissioner Jose Rodriguez if he had any questions in regards to the Consortium.
